**DRAFT RULES FOR RASHTRASANT TUKADOJI MAHARAJ
MEMORIAL FELLOWSHIP**

1. The R.T.M. Nagpur University shall award Rashtrasant Tukadoji Maharaj Memorial fellowship to the eligible applicant only.
2. Each fellowship shall be of the value of Rs. 5,000/- P.M. payable six monthly in arrears on submission of six monthly progress report by the recipient.
3. The fellowship shall be awarded for the maximum period of 2 years payable to those who are registered research scholars in this university. The “Students shall be tenable for a period of two academic year appropriate cases” The period of fellowship may be extended to one year as per the recommendation of concern H.O.D. as the decision taken by the Management Council in its meeting held on 19 March, 2013 Vide Item N0. 101.
4. The fellowship shall be open only to the bonafide residents of the geographical jurisdiction of the R.T.M. Nagpur University, Nagpur and also those who have had their entire education (under graduate and post graduate) in this university.

AMMENDED CLAUSE 5 & 9 to be included in THE DRAFT RULES FOR RASHTRASANT TUKADOJI MAHARAJ MEMORIAL FELLOWSHIP

Clause -5. (to be amended as follows).

- The total number of fellowships awardable annually shall be 50 (fifty) of which 5 (five) each shall be for the existing 09 (nine) faculties in vogue in the University. The remaining 05 (five) shall be distributed in equal number among the faculties where number of applications are more.
- i) Provided further that subject wise allocation under the faculty may be notified by the university as is decided by the competent authority from time to time.
 - ii) Further if the allotted fellowships to any of the faculty are not exhausted fully, in such circumstances the remaining un-exhausted fellowships of that faculty may be diverted to other faculties in equal number where the numbers of applications are more. The distribution of the fellowships should be made on merit basis.
6. The University will publish an advertisement in at-least one each English, Hindi & Marathi leading daily within 1 month from the conclusion of the research recognition committee meeting in all the faculties in the university.
 7. The applications so received would be scrutinized by the Three member Committee which shall be constituted by the Vice-Chancellor of the university for the said purpose. The applications received by the Deputy Registrar (Development) shall be place before the Committee within 30 days from the last date of receipt of application.
 8. The Committee shall scrutinize the applications and recommend them for the consideration and approval by the Vice-Chancellor of the University. The recommendations made by the committee shall not be open for any further review, in as much as the recommendations so made shall be final, binding and conclusive.

10. The annual income from all the sources of the parent/guardian of the applicant shall not exceed Rs.2.00 Lacks per year.
11. While granting admission to students to Ph. D. Programmes, the department/institute/school will pay due attention to the National/State Reservation Policy.
12. The applications shall be routed by the applicant through his research guide/supervisor forwarded by the principal/head of the department, as the case may be.
13. The fellowship shall not be awarded along with any other fellowship/scholarship accruable to the applicant. A declaration to that effect will have to be made by the applicant in the application.
14. The holder of the fellowship shall refund the money received by him/her towards the fellowship in case he/she discontinues research work before the completion of two years. An undertaking to this effect will have to be furnished by the applicant at the time of award of the fellowship.

REPORT OF THE COMMITTEE
