As per Section 40 (6) of the Maharashtra Universities Act, 1994, on behalf of the Management Council, Hon'ble Vice-Chancellor has fixed the following dated for constitution of Student's Council of University Departments and Student's Council for each affiliated and conducted College/Institution under Section 40 (2) (a) and (b) and election of secretary as per Section 40 (3) of the Act.

- (1) 21st August, 2009 as the date of constitution of Students Council of Affiliated/conducted Colleges/Institutions and University Departments Student's Council.
- (2) 27th August, 2009 the date of first meeting of the Student's Council to elect Secretary amongst the nominated student members.

In case of any dispute arising from the election of Secretary, it shall be decided by a Committee constituted by the Hon'ble Vice-Chancellor comprising of :

Formation of Student's Council U/S 40(2)(a) and 40 (2) (b) of the Maharashtra Universities Act, 1994 for the year 2009-2010.

U/S 40 (1) of the Maharashtra Universities Act 1994, the Nomination of Student Member's on the Student's Council shall be made every year as soon as possible after Commencement of academic year and for this the date to be fixed by the Hon'ble Vice-Chancellor.

According to Direction No. 5 of 1996, clause 4 (a), the Nomination of Student Members shall be made every year by the respective chairman U/S 40 (2) (a) and 40 (2) (b) of the Act.
