NOTIFICATION

It is notified for general information of all concerned that the Hon'ble Vice Chancellor has approved the recommendation of meeting of Special Task Committee in Business Management & Business Administration under the Faculty of Commerce & Management in its meeting held on 23.04.2018 and concurred by the Dean, Faculty of Commerce & Management, regarding submission of examination forms of students who have passed MBA Semester I,II and III examination under Direction No. 22 of 2012 (CBS) but could not appear Semester IV examination in regular attempts and are now eligible to appear for semester IV examination.

Direction No. 22 of 2012(CBS) had some specialization subject are viz, Information Technology Management, Healthcare, Agri Business Management, Power Management and Environment. Hence, while absorbing the students of CBS (old) syllabus who had opted for any of the above mentioned specialization subject are related to service sector Management to a reasonable extent. Therefore, it is decided that all such students shall appear for either 'Healthcare Management' under Service Sector Management Group or Total Quality Management under Operations Management Group as an equivalent subject for their Second Specialization Group.

According the examination forms of such students shall be accepted and their results shall be declared in accordance with the norms prescribed in Direction No. 2 of 2017 to be implemented from the session 2017-2018. The said notification is issued Under Section 12 (7) of Maharashtra Public Universities Act, 2016 on behalf of Board of Studies in Business Administration & Business Management, Faculty of Commerce & Management, Academic Council and Management Council.
